



Mega Slip and Slide Disclaimer Form

I understand and agree on behalf of all Releasing Parties, as follows:

1. Parties: Releasing Parties include: the participant(s) named below and their family members, guardians, heirs, next of kin, and anyone else who might claim or sue on the participant(s), behalf or for injury to the participant(s), including any representatives, successors and assigns, or insurers.

Released Parties include Neat Promotions Ltd, Mega Slip and Slide and employees, directors, owners, contractors, insurers, spectators, equipment suppliers, volunteers, any parent, subsidiary, or affiliated companies.

2. Acknowledgement of Risks: I understand that there are risks associated with participation and use of Neat Promotion's Mega Slip and Slide and items on the event site within the common areas. In particular multiple sliders using the slide at the same time with or without equipment can substantially increase risk of injury.

All participants agree to watch / and or read and follow posted signs and verbal instruction of the slide staff at all times whilst in the event premises/area & fully understand the slide safety information in all formats.

I know the nature of the Slip and Slide activity and I understand that not all risks can be eliminated.

3. Potential Injuries & Medical Conditions: All participants must be confident within water. The risks of participating in the slide / event activities are extensive / significant and may cause minor, serious and catastrophic injury to a person or damage to property.

These could include but are not limited to: head injury, sprains, stains, burns, cuts, bruises, drowning, or near drowning. Accidents and / or injury involving but not limited to falling, slipping, sliding, running, travelling / movement with or without equipment. Catastrophic injuries can include but are not limited to the following: permanent disabilities, spinal injuries, heart attack, stroke and even death.

I understand that by participating, I will be slip & sliding within chlorinated water and the potentiality of mud and other substances, which may not be tested for chemicals or treated for disease or illness. I understand that Neat Promotions Ltd or its employees & directors cannot be held responsible or liable for any person visiting our premises / site, participants or spectators or anyone using our equipment for the contraction or transmission of any disease or illness.

I understand the types of injury that might result from engaging in the slip & slide activity. I understand the demands relative to my physical condition. It is my responsibility to consult with my doctor before participating in the slide event to ensure that my participating will not pose any unusual risks to my health or well-being. I do not have any conditions that would be made worse by participating in the slide event. Any medical treatment resulting from my participation shall be at my own expense.

4. Assumption of Risks & Indemnification Agreement: I assume all the risks of participating and I take full responsibility for any and all damages, liabilities, losses or expenses that I may incur as a result in participating, both known and unknown. I voluntarily and forever waive, release, covenant not to sue Neat Promotions Ltd, and discharge the released parties from any and all claims resulting, in whole or in part, from the risks of participating in the slip and slide activities or from the ordinary negligence of any of the released parties.

I agree to hold harmless, defend and indemnify the released parties from and against any and all claims made by me, any co participants, rescuers and others, arising from injury or loss due to my participation in this activity.

5. Severability and Integration: If any part of this document is found to be unenforceable, then the provision is severed from the agreement and does not affect the validity of any remaining parts.

6. Cancellation: If the activity is cancelled, postponed or modified due to weather conditions, acts of God or other factors beyond the control of any releasee.

6.1. Force Majeure Policy - Adverse Weather Conditions:

6.1.1. Safety Prioritisation: The safety and well-being of all participants and staff are of utmost importance to us. In the event of adverse weather conditions, we reserve the right to close or suspend operations to ensure the protection of everyone involved.

6.1.2. Operational Conditions: While we aim to provide our services even during rainy weather, there are certain circumstances in which operations may be suspended. High strong winds, thunderstorms, and lightning overhead are considered hazardous conditions, and under such circumstances, we cannot operate.

6.1.3. Real-Time Decision Making: Given the changeable, localised, and unpredictable nature of weather, we may need to make last-minute decisions regarding closures. These decisions will be made in the interest of safety and without prior notice.

6.1.4. Pre-emptive Monitoring: We diligently monitor weather conditions, enabling us to anticipate potential closures in advance. To stay informed, we encourage participants to check our official Facebook page or our answerphone before travelling to our site.

6.1.5. Regional Discrepancies: Please be aware that weather conditions at our site may differ significantly from those in your area. Therefore, even if conditions are favourable locally, we may still need to close or suspend operations at our location.

6.1.6. Notification Procedures: In the event of cancellation, participants will receive an email allowing them to reschedule their booking or request a refund. However, if no communication is received, we request participants to proceed to the site as scheduled for their session.

6.1.7. Timely Decision-Making: As weather reports can change rapidly, we will make the decision on potential closures or suspensions in the early morning, ensuring ample time for participants to be informed.

By participating in our activities, you acknowledge and agree to abide by the Force Majeure Policy, particularly in situations involving adverse weather conditions. Your safety remains our primary concern, and we appreciate your understanding and cooperation in this matter.

7. Dismissal: I acknowledge and verify that I may be dismissed from participation, without refund, if I endanger the safety or negatively affect the Event, a person, a facility or property of any type or kind.

8. Audio Visual Recording and Photography Consent: By signing this form, you consent to Neat Promotions Ltd. to take video recordings and photographs of any of the participants named on this form or any spectators visiting our premises which may be used for the general publicity, to be displayed and used on our website or our associated social media sites. We do not and will not take photos of you or your party directly (being a subject or focus of a photo or recording) without permission. The disclaimer is only in place to protect us if you or your party appear in the background of a photo or recording.
