I, on behalf of all Releasing Parties, hereby acknowledge and agree to the following terms:

1. Parties

Releasing Parties include the participant(s) named below, as well as their family members, guardians, heirs, next of kin, and anyone else who may assert claims or legal actions on behalf of the participant(s) due to injuries, including representatives, successors, assigns, or insurers. Released Parties encompass Borne Events Ltd. and Slide, along with their employees, directors, owners, contractors, insurers, spectators, equipment suppliers, volunteers, any parent, subsidiary, or affiliated companies.

2. Acknowledgment of Risks

I understand that there are inherent risks associated with participating in and using Borne Events Ltd.'s Slide and items on the event site within the common areas. The simultaneous use of the slide by multiple sliders, with or without equipment, can significantly increase the risk of injury. All participants agree to carefully observe, read, and adhere to posted signs and verbal instructions provided by the slide staff at all times while on the event premises/area. I fully comprehend the safety information concerning the slide in all available formats. I am aware of the nature of the Slip and Slide activity and understand that it is impossible to eliminate all associated risks.

3. Potential Injuries & Medical Conditions

All participants must be confident in water. Participation in the slide/event activities carries extensive and significant risks that may result in minor, serious, or catastrophic injuries to individuals or property damage. These risks include, but are not limited to, head injuries, sprains, strains, burns, cuts, bruises, drowning, or near-drowning incidents. Accidents and injuries may occur during activities such as falling, slipping, sliding, running, and moving with or without equipment. Catastrophic injuries can include but are not limited to permanent disabilities, spinal injuries, heart attacks, strokes, and even death. I understand that participating involves sliding within chlorinated water and potentially encountering mud and other substances that may not have been tested for chemicals or treated for disease or illness. I acknowledge that Borne Events Ltd, its employees, and directors cannot be held responsible or liable for any person visiting our premises/site, participants, spectators, or anyone using our equipment for the contraction or transmission of any disease or illness. I also understand the types of injuries that might result from engaging in the slip & slide activity and recognize the physical demands it places on my condition. It is my responsibility to consult with my doctor before participating in the slide event to ensure that my participation does not pose any unusual risks to my health or well-being. I confirm that I do not have any medical conditions that would be exacerbated by participating in the slide event, and any medical treatment resulting from my participation will be at my own expense.

4. Assumption of Risks & Indemnification Agreement

I willingly assume all risks associated with participation and accept full responsibility for any damages, liabilities, losses, or expenses I may incur, both known and unknown. I voluntarily and permanently waive, release, and covenant not to sue Borne Events Ltd and discharge the Released Parties from any and all

claims, whether in whole or in part, arising from the risks associated with participating in slip and slide activities or from the ordinary negligence of any of the Released Parties. Furthermore, I agree to indemnify and hold the Released Parties harmless from any claims made by me, any co-participants, rescuers, or others arising from injury or loss due to my participation in this activity.

5. Severability and Integration

If any part of this document is deemed unenforceable, the unenforceable provision will be severed from the agreement, and its removal will not affect the validity of any remaining provisions.

6. Cancellation

In the event of activity cancellation, postponement, or modification due to weather conditions, acts of God, or other factors beyond the control of any releasee, no refunds will be granted.

7. Dismissal

I acknowledge and verify that I may be dismissed from participation, without refund, if my actions endanger the safety or negatively affect the Event, individuals, facilities, or any type or kind of property.

8. Audio-visual Recording and Photography Consent

By signing this form, I grant consent to Borne Events Ltd to take video recordings and photographs of any participants named on this form or any spectators visiting our premises. These media may be used for general publicity, displayed, and featured on our website or associated social media sites. If I wish to have any images removed, I will contact info@borneevents.com.
